TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1973

WHEREAS

- (1) the County Council of the Administrative County of Kent (hereinafter referred to as "the County Council") is the Local Planning Authority for the said County for the purposes of the Town and Country Planning Act, 1971;
- (2) the County Council is satisfied that it is expedient in the interests of the amenities of the area that development of the description set out in the Schedule hereto should not be undertaken on land formerly part of Townsend Farm in the Parish of St. Margaret's-at-Cliffe in the Rural District of Dover such land being shown coloured pink on the plan annexed hereto (hereinafter referred to as "the land") unless permission therefor is granted on an application in that behalf

NOW THEREFORE the County Council in pursuance of the powers conferred upon it by Article 4 of the Town and Country Planning General Development Order, 1973, and of all other powers enabling it in that behalf HEREBY DIRECTS that the permission granted by Article 3 of the said Order of 1973 shall not apply to development of the description specified in the Schedule hereto in, on, over or under the land or any part or parts thereof

THIS DIRECTION may be cited as the Kent County Council (Dover Rural District) Town and Country Planning Direction No. 1, 1974.

SCHEDULE

The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit, being the aforesaid land formerly part of Townsend Farm, St. Margaret's-at-Cliffe of building or engineering operations requisite for the use of that land for the purpose of agriculture being development comprised within Paragraph 1 of Class VI of the First Schedule to the Town and Country Planning General Development Order, 1973 and not being development comprised within any other Class.


